Thank you for inquiring about FMAA Summer Karate Camp. This is the second year we are offering camp and are looking forward to having a fun time!

To complete your application process, you will need to:

1. **Pay your deposit and registration fee to secure a spot in the camp***. For current students there is no registration fee required. A \$25 non-refundable deposit will hold your slot. For non-students, the registration fee and deposit for this summer camp is \$150, which includes the first week of camp. For any subsequent camps a \$25 non-refundable deposit is required.
2. **Complete and return your registration form.** Fill out the attached Medical Information Form, and then return it to our office.
3. **Complete and return your billing paperwork.** Fill out and sign the attached Billing Authorization form and attach a voided check to the form or present your credit card when you return the form to our office.

What goes on at Family Martial Arts Academy Camps?

Camp actually begins at 8:30 AM during the summer (during the summer, we allow for early drop off as early as 7:30 AM and late pick-up until 5:00 PM). During summer camp, all students must be picked up by 5:00 PM.

Please note that parents that pick their children up late will be charged at a rate of \$10.00 per 15-minute period they are late. Also note that students who are picked up late will be expected to participate in our regular classes after Camp activities end.
